DESCRIPTION OF EACH CATEGORY

- **Trade Contractor of the Year (Hispanic-Owned)**

1st tier contractor who excels in being an intricate part of the success of a project by providing specialized industry services, environmental responsibility and disposition to adopt the best practices and technologies, with on-time delivery and minority participation, if applicable.

- **Subcontractor of the Year (Hispanic-Owned)**

2nd or 3rd tier subcontractor who excels in being an intricate part of the success of a project by providing specialized industry services.

- **Remodeler of the Year (Hispanic-Owned)**

Contractor who stands out for providing high quality construction services to residential clients, with excellent customer service, environmental responsibility and disposition to adopt the best practices and technologies.

- **General Contractor of the Year**

Contractor whose exemplary collaborative efforts render a consistent high-quality product for the best value with on-time delivery.

- **Associate of the Year**

Company or individual who has made significant contributions to HCAC members that enables growth and success of Hispanic firms.

- **Safety Champion (Hispanic-Owned)**

Company whose safety culture and practices serve as an example to all other construction businesses for embracing the safety of their workers in the jobsite.
